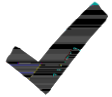

£49k surplus



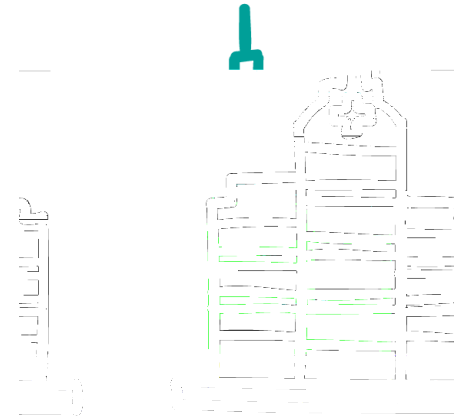
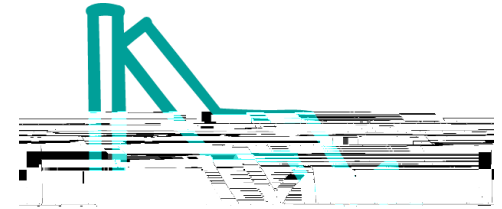
Covid meant an additional £3.1m of income was received by the Trust to cover testing and vaccination programmes

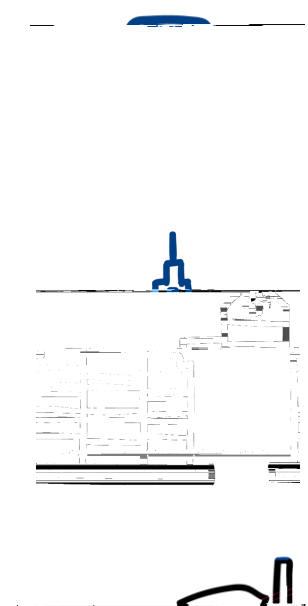
